- Sealed Bids must be submitted to the above office of *Lumbini Cultural Municipality, Office of the Municipal Executive, Lumbini, Rupandehi* on or before 11:59 hours on 9th Jan. , 2019 (25 Pausa, 2075 BS). Documents received after this deadline shall not be accepted. Late bids will be rejected.
- Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on on 9th Jan. , 2019 (29 Pausa, 2075 BS) at the office of *Lumbini Cultural Municipality, Office of the Municipal Executive, Lumbini, Rupandehi*. Bids must be valid for a period of [ 90 days] counting from the day of bid opening and must be accompanied by bid security amounting to a *minimum of 155,000/-*, which shall be *valid for minimum 30 days* beyond the bid validity period. The original bid bond guarantee letter should be issued in the name of the office by any Commercial Bank, recognized by the Government of Nepal. Only the bid security guarantee letter in the format specified in the bid document will be accepted. Information to deposit the bid amount in the bank.
